To Whom It May Concern:

4Life Research USA, LLC ("4Life") recently commissioned the testing of 4Life's 4LifeTransform<sup>®</sup> Pro-TF<sup>®</sup> product by an internationally-recognized, ISO-certified banned substances testing lab, BSCG (see [www.bscg.org](http://www.bscg.org); see attached report). BSCG has tested for banned substances in dietary supplements for over 10 years. They offer a certification program utilized by companies worldwide to assure athletes that they are not consuming anything that would get them banned from competition. Additionally, BSCG has been instrumental in setting up drug testing programs for the NFL, MLB, NCAA, and other sports organizations.

The testing performed at BSCG looked for 72 of the most common anabolic agents (see <http://www.bscg.org/testing-menu/>) using state-of-the-art liquid chromatography/mass spectroscopy methods which allow detection of these compounds in amounts as small as 0.001%. The attached report clearly states the lack of any of these substances within an unopened, intact bottle of 4LifeTransform Pro-TF using these test methods.

4Life encourages its customers and distributors to be informed about the supplements they take. In addition to following FDA-mandated good manufacturing practices (GMPs), 4Life has a rigorous process for qualifying vendors and the ingredients they supply us to ensure the identity, strength, purity, and composition of our products. We also take special care to make certain that only the most reliable and repeatable testing is done on our products, including the aforementioned banned substance screening.

It is the opinion of the Research and Development and Quality Departments of 4Life, that the attached analysis is a true representation of the lack of steroids or other anabolic compounds within 4Life's 4LifeTransform Pro-TF powder. 4Life is committed to providing the highest quality and safest products on the market and we stand behind the products we make.

### ANALYTICAL REPORT

**Reason for Analysis:** Banned Substances Control Group (BSCG) was asked to perform testing on a dietary supplement item to evaluate the presence of anabolic steroids and related drugs.

**Receiving:** On September 3, 2015 a package was received intact with no signs of tampering at our ISO 17025 accredited laboratory partner. The package contained an item identified as follows:  
PRO TF, Malaysia - 127CN5A

**Analytical Method:** Samples of the item were extracted and analyzed according to in-house methods for nutritional supplements using instrumental screen by liquid chromatography/mass spectrometry (LC/MS). The testing menu included more than 72 Anabolic Agents, see list of compounds on page 2. Method detection levels, which vary based on matrix analyzed, are estimated to be in the 10-250 ng/g range for most compounds in most supplement items.

**Analytical Findings:** No compounds were detected in the item.
